# D. Tennis

- 1. Cam handed out the League results for the first 10 matches. Currently Armijo and Napa are tied for first.
- 2. Joan will check with the Section to see how the 3<sup>rd</sup> set competition is held during play-offs ie: tie breaker or regular play.
- 3. In the tennis by-law (10.2-3) the sentence "The number six (6) position can be played by anyone on the team. " was deleted. The ADs vote was unanimous. 10.2-3 now reads: "The best player shall at all times play as the first single player. Each school must establish a entire team singles' ladder through player competition. The coach may not subjectively set the ladder; the positions on the ladder must be earned through a playoff-type situation roundrobin tournament. Once the ladder has been established the best player must play at the number one (1) singles position, second best at number two (2), third best at number three (3). Changes may be made to this ladder by having challenge matches after each round of League play. Results of the challenge matches must be available for review by the AD in charge of tennis. After the singles positions have been established, any combination of players may be used for doubles provided the number one (1) doubles team is stronger than the number two (2) team and the number two (2) team is stronger than the number three (3) team."
- 4. The thirds round of League play started September 29<sup>th</sup>. Any school not turning in their ladder information by 3 p.m. to the AD in charge of Tennis will required to continue to use the same ladder as was used in round 2.
- 5. Each school is **required** to play the submitted ladder. In case of injury, illness or coach's discipline, by-law 10.2-7 allows the coach to use his/her discretion on substitution. However, those players already listed on the playing ladder **may not** be moved into the vacated position.

  - 1. The first League tournament was held at Paradise Valley Golf Course on Tuesday, September 27<sup>th</sup>. Everything was fine.
  - 2. The coaches have agreed that players reaching double par before reaching the green will pick up and drop the ball on the green. The maximum score for a par 3 is 9, for a par 4 is 11 and for a par 5 is 13.
