- II Recommended Action (Voting)
 - A. Support Groups
 - 1. Fairfield motioned to accept the proposed bylaw. Wood seconded the motion.
 - 2. Discussion requested regarding designating specific basketball allowable numbers. Each school then declared the acceptable number of visiting cheerleaders for their facility.

- B. Golf By-law 12.8-1
 - 1. Joan explained what brought about the need for the additional golf bylaw. Working with a USGA rules official the proposed bylaw will be used for both boys and girls golf tournaments.
 - 2. Armijo motioned to accept the proposed golf bylaw as presented. Wood seconded the motion. Vote unanimous.

C. New Business (Non voting Items)

1. Sac-Joaquin Section

a. Revision to bylaws 1502.1d,1502.1e, 2600.5 &2600.6 Baseball/Softball suspended game.

Proposal is for games called for weather or darkness be considered suspended games that will resume at the point of being called.

b. Revision to bylaw 1502.1a and addition of bylaw 2601.1c Baseball/Softball Pregame Batting Practice: Post Season

Proposal is to definitively define pregame batting practice and to establish a specific bylaw for softball. This proposal will keep policies consistent between baseball and softball.
