# I. Fall Sports

- A. Football
  - 1. League games start next week
  - 2. All league meeting will be October 30<sup>th</sup>. More information at the next AD meeting.
- B. Volleyball
  - 1. Round 2 started September 18
  - 2. Currently Vacaville & Vanden tied for 1st
  - 3. 3 teams will go to playoffs
- C. Girls Tennis
  - 1. Some schools were sending lineup instead of ladder; this error has been corrected.
  - 2. Fairfield will host the MEL tournament. Joan will contact Cam Neal from Vintage and try to get official information.
- D. Water Polo
  - 1. 2 boys teams and 2 girls teams will make Section playoffs.
  - 2. As of today water polo has completed 1 round of the 3 played in league.
- E. Girls Golf
  - 1. The  $1^{st}$  league tournament is taking place today at Rancho Solano and the  $2^{nd}$  league tournament will be October  $11^{th}$  at Cypress Lakes.

2. ## .F. Cross Country

- 1. September 26 will be the first center meet at Lagoon Valley Park. Each school needs to register their athletes on line at athletics.net using the information that Kay Nekota sent each coach. Registration deadline is Sunday September 23<sup>rd</sup>, 11:59pm.
- 2. City of Vacaville charges a fee for the use of Lagoon Valley for the Center meet and the MEL Championships. Kay will send each school an invoice for 1/6 of the cost for the two meets.
- 3. The visiting school in dual meets should contact the host school the Monday before the meet to declare if they have complete teams in each of the running categories. Pre notice of team size allows the host school to prepare for combining races if the numbers allow.
- 4. For dual meets the host school needs to be sure that the course is chalked so that runners do not get lost. Sending electronic maps of the course is acceptable but the there should be some hard copies available at the venue
