C. Fairfield motioned to accept the minutes of August 28th, 2019 as posted. Armijo seconded the motion. Vote unanimous.

II Recommended Action (Voting)

A. 2019-2020 Budget

Joan reviewed the budget, addressing any changes from previous budgets.

Wood motioned to accept the budget as presented. Vacaville seconded the motion. Vote unanimous.

B. Removal of Bylaw 1.9-5.1

This bylaw deals with Frosh football players moving to JV team. The bylaw said that once moved the player must remain on the JV team. With Section bylaw 503.7 stating a player may move from one classification to another during the season, it was determined by the Athletic Council that the current league bylaw was obsolete.

Armijo motioned to delete bylaw 1.9-5.1. Wood seconded the motion. Vote unanimous.

C. Revision of Tennis Bylaw 11.4.6

Joan reviewed the current method to award all league status to the tennis players which is solely based on the results of the end of the season league tournament. The proposed method of selection will be based on the total dual meet season with nomination and voting by the coaches to select the 12 all league players.

Vanden motioned to accept the revision to bylaw 11.4-6. Vacaville seconded the motioned. Vote unanimous.

1. Budget Adjustment for 2019-20.

There was a short discussion as this had been reviewed by Ryan Tos at our previous meeting. Armijo motioned to accept the recommended budget adjustment. Vacaville seconded the motion. MEL board indicated a YES vote.

C. Additional Comments/Questions

- 1. Clarence Isador has been placed on the Sac Joaquin Section Fiscal committee for 2019-20.
- 2. Question: How does each district deal with students from other schools (not either of competing schools) in terms of home side access during football games.

a. FUSD policy dictates that only home team students may be on the home side. All other spectators must be on the visiting side of the field.

b. Vacaville schools and Vanden have no hard fast rule regarding home vs visiting side of field. Vacaville schools do however do not allow students to move back and forth between sides during the game.

c. Vacaville and Fairfield schools do request to see Student IDs when entering the stadium. In addition middle school students must be accompanied by a parent/guardian.
