I. Fall Sports

A. Football

1. ByLaw 1.9-5.1 which stated a freshman moving to JV team must stay there for remaining games. By a vote of 6-0 the recommendation is for this bylaw to be removed as players changing teams is addressed in bylaw 1.9-1.

2. Chris Santopadre will work on updating the football bylaws. The suggested updates to the bylaws will be presented to the coaches at the all league meeting at the end of the season. Once the football coaches have had input Chris will bring the recommendations to the athletic council for review.

C. Girls Tennis

1. All League Section—the tennis coaches unanimously recommend that the all league selection process be changed to a voting of all league recipients by the head coaches rather than using the end of season league tournament.

The Athletic Council voted 6-0 to recommend that the current bylaw 11.4-6 be replaced with the coaches voting procedure.
