I Spring Sports

A. Badminton –

1. The league tournament was moved to today's date to accommodate Davis High athletes that had qualified for a state speech competition.
2. There was a short discussion about whether the league tournament could be held over a 2 day period much like tennis currently does. The discussion included: possible late start time so students were not out of school, possible venue problem, would transportation be an issue.
We need to get input from the coaches regarding a 2-day event before we discuss this further.

B. Baseball

1. Playing during Spring break.

Cam talked about formulating a bylaw that would prohibit league games during the designated league spring break. This recommendation is really about pitch count and required days of rest. Playing a league game during break could be viewed as "gamesmanship" by other coaches. This item was sent to the end of season baseball meeting for discussion and recommendations.

C. Boys Golf

1. The 2nd League Tournament will be May 2nd at Paradise Valley. Please have the coach bring a check made out to Paradise Valley Golf Course in the amount of \$20/player.
2. Monday May 8th the MEL hosts the Section Division1 North tournament at Rancho Solano Golf Course. The tournament is under the direction of Cory Roche from Napa High.

D. Softball—

1. Currently there is a 3-way tie for first place between Napa, Vacaville and Wood. Vintage is also in position to move into 1st place as well. Athletic Directors are asked to review the league tie breaker procedure, general rule 1.23, with their coach so that he/she fully understands the procedure.

- F. Swimming / Diving
 - 1. Currently Vintage girls and Rodriguez boys are in 1st place in league competition.
 - 2. There have been no further complaints regarding the diving competition being held Tuesday before the Wednesday dual meet swim dates. Tracy will meet with the coaches at the end of the season regarding schedules and other concerns.
