II Old Business
Schedules 2010-2011

1. Vacaville motioned to accept the schedules for 2010-11 as follows:

III Emergency Items
Vintage motioned to accept contingency schedules for 2010-2011 as an emergency item. $2^{\text {nd }}$ by Wood. Vote Unanimous.
A. Armijo/Fairfield Sports 2010-2011

1. Eric Tretten gave a review of the current status of athletics in the Fairfield-Suisun Unified School District.
a. Currently, the FSUSD board has declared that athletics will not be funded for the 2010-2011 school year. For the sports programs to exist, $\$ 720,000$ must be raised by July 1, 2010.
b. A public education foundation is being organized to help with future expenses.
c. A group called SOAP (Save Our Athletic Programs) is trying to raise money through donations from:

Local Businesses
Outside Businesses
Parent and Community donations
d. According to FSUSD, the majority of the funds needed are for stipends (which is a negotiated item).
2. Barb Franco inquired if the League should send a letter to the FSUSD Board in support of keeping athletics for the students of Armijo, Fairfield and Rodriquez.

3. Eric Tretten asked that the Napa/Vintage transportation plan be included with the League's letter of support.
