II Emergency Item

A. Old Business Section

1. Basketball Power Rating

After a discussion, a role call voted was held. The vote was 5-1 in favor of supporting the SCAC proposal.

C. New Business Section - Voting January 2012

1. Co-ed Tennis -- Did not discuss - N/A to MEL
2. Rodriquez Play-Off Proposal

There was a lengthy discussion on this issue. The SCAC asked the MEL to review a proposal that they thought might better meet the issue:

## Rodriquez Play-off 2012-14 <br> SCAC Proposal

The SCAC is proposing that during the 2012-13 and the 2013-14 school years that instead of Rodriquez just coming to the MEL for the league tournaments in wrestling and track that there actually be a member swap in those two sports.
SCAC is proposing:

1. One of the MEL schools, move to SCAC for the last two years in wrestling and track.
2. Each school that is moving for those two sports will compete in the dual meet process with the league they are in.
3. Both of the schools that move, Rodriquez and 1 MEL school, will have the opportunity to qualify for Sections as a member of the division that they are competing in.
4. At the end of this realignment 2013-14 one MEL school will be most likely be moved to SCAC as per Section indication.

After reviewing the SCAC proposal, the consensus was that the MEL had no school willing to leave for wrestling and track.

The MEL determined what was unacceptable regarding the Section proposal. (See following insert.) Two alternative plans were suggested for the Rodriquez play-off issue:

## Sections ---Rodriquez Play-Off Proposal

The Section proposal that has Rodriquez join into the MEL league tournaments in wrestling and track creates some major issues.

1. The MEL seeds the wrestling tournament according to dual meet results within the league. Rodriquez would not have any MEL dual results. Seeding would then be a concern for all participants
2. Rodriquez would potentially take Section qualifying spots from MEL athletes in both wrestling and track.
3. The Section is satisfying Division III issues (removing a dominate school) while creating a problem for the MEL. Should every dominant school be forced to another division? Where does this stop?

## MEL Proposal:

The MEL is suggesting 2 possible alternative plans. The MEL Board of Managers lists the plans in the order of preference.

1. Keep the integrity of both the MEL and SCAC. Rodriquez would compete in the SCAC for both dual meets and league tournaments. Any Rodriquez Section qualifier would automatically be moved to compete at the Division I level, in Section play offs. The next SCAC participant in line for that event/weight class would fill the league-qualifying spots vacated by Rodriquez.
2. Place Rodriquez into the MEL for only wrestling and track making a 7-team league for 2012-13 and 2013-14.
3. Girls Volleyball Proposal No one voiced any questions regarding this proposal.
4. Charge for Scrimmages

All schools are basically in favor of admission charges. The question comes up: Will the officials want to paid because there is an admission charge?
