I Fall Sports

A. Football

1. Scrimmages are currently being held.
2. Napa is playing August 26th during “zero” week.

B. Volleyball

1. Triple headers will be played for the four schools with frosh teams – Napa, Vacaville, Vintage, and Wood.
2. Frosh game time will be 3:45 but may be changed for the rival game.

C. Soccer

1. All scrimmages are finished since League starts on Friday August 26th.
2. For each home game, the Officials’ Association is requiring a “contact” person for use in case of problems.
3. The following schools will be charging admission:

Vacaville
Vintage
4. Wood will charge admission for the rival game.
5. Napa and Vintage will play home contests at Memorial Stadium.

D. Tennis

1. League starts Friday, August 26th.
2. Each coach will do a ladder exchange in writing for all League matches.
3. By-law 10.2-8 will be enforced. Each school is required to submit to Cam Neal a copy of the school’s complete ladder for each round of play.
For round 1, if there is no ladder submitted, the positions in the first League game will constitute the ladder for Round 1.

1. All coaches were present at the pre-season meeting held August 23rd. The schedule was reviewed at the meeting.
 2. For the 2 League tournaments, each school will be billed \$120 per tournament to cover facility charges.
