Commissioner Joan Mumaugh called the meeting to order at 8:40 a.m..

Present: All Athletic Directors were in attendance.

I Fall Sports

A. Football Fred will send an updated coaches list with phone numbers included to all current football coaches.

B. Volleyball

1. Vacaville vs. Wood and Napa vs. Vintage will be played on November 1, 2006 not October 31, 2006 as originally scheduled.
2. All league coaches meeting is still scheduled for November 2nd.

C. Soccer

1. Bob Baclig stated that he still has not received all the varsity rosters as requested.
2. Bob reviewed new by-laws for soccer. Bob will review these by-laws with the boys' coaches in the Fall and with the girls' coaches in the Spring. New by-laws will be introduced at the January Board of Managers meeting.
3. Any by-law changes would become effective for the 2007-2008 school year.

D. Tennis -- Vintage will host League singles and doubles tournament. Coaches are required to attend a 8:00 a.m. meeting on the first day of the tournament.
