May 27, 2010

Commissioner Joan Mumaugh called the meeting to order at 8:35 a.m..

Present: All Athletic Directors were in attendance except Ed Williams.

I Spring Sports

A. Badminton

The League tournament was held at Vacaville High on May 18th. Everything went well.

B. Baseball

The League ended with a 4-way tie for 2nd place. Using the head-to-head portion of the tie-breaker system determined the 2nd place team for the Section tournament.

C. Golf

Aaron Beverly from Armijo was the only MEL player to qualify for the NorCal tournament.

Aaron just missed a trip to the State tournament.

D. Girls Soccer

Both MEL representatives lost in the first round of play-offs.

E. Softball –

The MEL had two teams qualify for the Section tournament. One team was eliminated in Round 2 and the other team was eliminated in Round 3.

F. Swimming / Diving

There was a tie for the girls championship between Napa and Vacaville. Vacaville receives the ordered pennant.

G. Boys Tennis

Armijo played Davis for the Section championship. Unfortunately, Davis again defeated Armijo for the title.

H. Track

1. The event registration for the League Meet had to again deal with athletes that were not listed on the entry form..
2. Extra workers are always needed to help with the variety of events. Mike Papadopoulos will put together a list of minimum/maximum people required for each event for next year's MEL Tournament.

II Fall Sports

A. Spring Football

1. Fred reminded everyone that during spring football no helmets, sleds or blocking dummies are allowed.
2. Football by-law 1.17 needs to be revised to align with the Section rule 1903.3.

B. Girls Tennis

The first date of competition will be Friday, August 27th to align with the Section starting date.

III Winter Sports

Wrestling

1. The novice tournament will be at Napa High on November 24th.
2. Napa received a letter of reprimand from the Section for participating in a tournament that did not conduct weigh-ins on the tournament start date.

IV Schedules 2010 – 2011

Both swimming and track schedules were distributed and reviewed.

The schedules will appear on the website as tentative until approved by the Board of Managers in September.

V School of the Year

For the 4th consecutive year Napa was awarded the School of the Year pennant.

VI Other

A. Gate Receipts for League Tournaments

1. Badminton, B/G Tennis, Golf, Swimming, Track, and Wrestling all involve League tournaments.
2. Admission to League tournaments is charged for Swimming, Track, and Wrestling.
3. The League by-laws do not indicate who (host school or League) should keep the gate receipts for League tournaments.
4. Mike Papadopoulos proposed that gate receipts, after expenses, should be returned to the League and not kept at the host site. The host site would keep any concession, program and tee shirt monies.
5. The Athletic Directors agreed with Mike as long as there was a financial report form submitted to the League from the host school.
6. Joan will provide the financial report form.
7. The Board of Managers will receive this item in September.

B. League Reps to the Section

Reviewed all League reps for the Section.

C. Meeting Calendar

The revised meeting calendar for 2010 – 2011 was distributed.

D. Website

The summer screen will go up June 1st. By June 15th, the 2010 – 2011 schedules will be available.

E. Football Camp Forms

Napa, Vacaville, Vintage have sent in camp forms for this summer.

F. Golf with Dixon

1. The Dixon AD contacted Joan asking if the Dixon girls golf team could be added to the MEL schedule.
2. Joan sent a note to Napa, Vacaville, Vintage and Wood asking if they would approve adding Dixon as a guest of the MEL. All four schools said that they approved.
3. Two schedules were presented (with different start dates) which included Dixon. The Athletic Council chose schedule A with starting date of September 9th.

4. Each school was instructed to get their Principal's approval to accept this new schedule in place of the original schedule.
5. During the MEL #1 Tournament, Dixon will play at the end of the groupings.
6. Dixon will not compete in the MEL #2 Tournament due to course constraints and day light.
7. Dixon was FAXed a copy of the schedule after approval was received via email allowing the schedule replacement.
