Commissioner Joan Mumaugh called the meeting to order at 8:30 a.m..

I Fall Sports

C. Soccer

D. Tennis

1. Ladder stacking
 - a. The AD of the school in question reported that he researched the questionable ladder. Challenges as allowed for movement were held on Saturday prior to the questionable League match.
 - b. Dave Shipp also reported that he had reviewed the line up cards of the school in question and the cards were the same for 4 consecutive matches.
 - c. After a lengthy discussion, Brian King made the following motion:
By law 10.2-3 should be amended to read: “Changes may be made to the ladder after each round of League play by having challenge matches. Seconded by Dave Shipp. Vote Unanimous.
 - d. Brian King also moved to amend 10.2-8.
Motion to: Remove the current 10.2-8 and replace it with “Before each round of League play a copy of each school’s complete ladder must be sent to the Athletic Director in charge of tennis. Failure to send a new ladder after a round of play will indicate that the ladder of the previous round is still being used.”
Second by Dave Shipp. Vote Unanimous.
2. Brian King motioned to amend 10.2-9 to read: “When players change sides and/or between sets, *only the designated* coach may confer with team players for a maximum of 90 seconds.”
Second by Dave Shipp. Vote Unanimous.
3. Dave Shipp motioned that any changes in the tennis by-laws be implemented during Spring Tennis, 2011. Second by Mark Wudel. Vote Unanimous.

4. Changes for tennis by-laws will be presented at the Board of Managers meeting on October 13th. (See attachment)
